

MEMBERSHIP APPLICATION RIDER AGREEMENT

Please Read Carefully

In consideration of becoming a member of Long Island Motocross, Inc., I will follow all the rules that apply to both non-competitive events. I understand the risk involved in the sport of motocross whether it be non-competitive or competitive. I understand that this is a dangerous sport and may lead to injury, paralysis, or even death. I acknowledge that I have to have my own vehicle and equipment and I am responsible for the condition of it before, during, and after.

I for myself, my heirs, personal representatives and assigns, hereby release, discharge and agree to hold harmless and indemnify Long Island Motocross, Inc., the promoters presenting events, the owners and lessees of premises on which events take place, the participants in events take place, the participants in events, the owners, sponsors and manufacturers of all equipment upon the premises and the officers, directors, official, representatives, agents, and employees of all of them, of and from all liability, loss, claims, demands and possible causes of action that may otherwise accrue from any loss, damage or injury (including death) to my person or property, in any way resulting from, or arising in connection or preparation therefore, or while upon entering or departing from said premises, from any cause whatsoever including without limitation the failure of anyone to enforce rules and regulations, failure to make inspections, or the negligence of other persons. I know the risks and danger to myself and property while upon said premises or while participating or assisting in an event, and I do so voluntarily and in reliance, not upon the property, equipment, facilities and existing conditions furnished by others, but upon my own judgment and ability, and I thereby assume all risk for loss, damage or injury (including) to myself and my property from any cause whatsoever and whether or not attributable to the negligence of others. I hereby certify that I assume all responsibility for all charges, premiums, taxes, if any, payable on any funds that I may receive as a result of my competition activities, including without limitation, social security taxes, unemployment insurance taxes, compensation insurance, income, taxes, and withholding taxes.

It is understood and agreed that in the even I am injured from whatsoever cause during an event authorized and operating under Long Island Motocross, Inc. rules, I herewith consent and authorize first aid and ambulance services provided by the sponsoring organization or property lessee or owner if any is available on premise, and further hold all parties harmless from any consequence of said aid.
